

► Duration of Study 學習期限

The MSScIED programme admits both full-time and part-time students. Full-time students will complete their studies in three semesters within 12 months, while part-time students will complete their studies in two academic years.

► Tuition Fee 學費

The tuition fee for MSScIED is around HK\$90,000 (HK\$1,500 per credit), subject to annual review by the University.
